# Recoverability:

This criteria considers actions taken to improve the recovery of packaging at end-of-life and increase use of reusable packaging.

60% of our packaging to be designed to have all packaging components be recoverable at end-of-life.

### Criteria 5:

# Disposal Labelling:

This criteria considers the extent to which packaging has been labelled to help consumers determine what to do with packaging at end-of-life.

60% of our packaging to have on-pack labelling to inform correct disposal.

#### Criteria 6:

### **On-site Waste:**

This criteria considers progress in increasing the amount of on-site solid waste being diverted from landfill.

- Have recycling programs for the following materials:
  - Paper/cardboard
- Aim for 30% of our on-site waste to be diverted from landfill.

### Criteria 7:

# **Problematic Materials:**

This criteria considers the extent to which organisations are actively phasing out problematic and unnecessary single-use plastic packaging and preventing/reducing litter.

- Phase-out the following problematic and unnecessary single-use plastic items:
  - Lightweight plastic shopping bags
